Local Planning Scheme 3

a) Ms Nicole Duncan, 8 Viewway, Nedlands

What steps will the City take to ensure that any scheme finally adopted by the WAPC does not dangerously increase density and traffic flows surrounding Nedlands Primary School, thus compromising child safety, in the way that the Draft Local Planning Scheme 3 clearly does?

b) Ms Kellie Husluck (Clarity, Director), 360 Rokeby Road, Subiaco

How will the City of Nedlands work with concerned residents, ratepayers and the Nedlands Primary School to amend the Draft LPS 2 to ensure the final town planning scheme meets the needs of residents and the school in the long term?

c) Mr Scott Ellis, 26 Viewway, Nedlands

What steps will the Council take to ensure that Draft Local Planning Scheme No 3 is amended so that it does not degrade the amenity and substantially alter the character of the City?

On a scale from 1 to 10, where 1 is very bad, and 2 is the present situation, just how disastrous will the traffic at the Broadway/Stirling Highway intersection become if Draft Local Planning Scheme 3 is imposed on the electors of Nedlands?

d) Mr & Ms Des & Caroline Marsh, 4 Bedford Street, Nedlands

What will the City do to address the inadequacies within LPS 3 with respect to the significant increases in densities between adjacent lots within the designated transition zones between RAC0 and R60 lots?

More specifically, what safeguards will be in place to ensure that significant differences in density on lots of equal area do not result in poor development outcomes with respect to bulk and scale, privacy, traffic flows and street scape?

e) Mr Alan Nicoll, Viewway, Nedlands

Why has increased dwelling density in the City of Nedlands under Draft Local Planning Scheme 3 not been achieved more fairly by focusing increasing dwelling density along established transport networks?

f) Ms Trina Russell, 17 Kingsway, Nedlands

What rationale did the West Australian Planning Commission (WAPC) put forward for altering the draft Local Planning Scheme submitted by the City of Nedlands to the WAPC, in favour of Draft Local Planning Scheme 3.

g) Ms Bronwyn Stuckey, 26 Kingsway, Nedlands

We acknowledge the over-arching Government policy to increase the density of dwellings in the Perth metropolitan area including in the City of Nedlands. Under Draft LPS3 the burden of the increased dwelling density in the City of Nedlands has fallen inequitably on the Kingsway and Viewway portions of the Melvista Ward rather than being distributed fairly and more evenly throughout the City. What steps can the City make to prevent this occurring and what steps will the City take to prevent this occurring?

h) Mr Ken Eastwood, 7 Alexander Place, Dalkeith

In what ways has the City of Nedlands been judged to have failed to meet the density requirements imposed on Councils by the Western Australian Planning Commission (WAPC) in order to achieve urban consolidation and better integration of land uses?

As a result of the government demand for increased density has the WAPC given the Council any guidelines as to how the various Government Departments propose to cope with the increased density demand on services such as water supply, electricity and sewerage?

What steps does Council now plan to take to ensure that the character and lifestyle of our City are maintained?

What assurance will Council offer the Nedlands Community that it will consult with them and represent their views and interests in the strongest possible manner in all future similar negotiations? i) <u>Ms Elaine Jacoby, 29 Jutland Parade</u> (3 minutes)

Response regarding Local Planning Scheme 3 from the City of Nedlands

Mr. Peter Mickleson, Director Planning and Development addressed the meeting and provided background to the development of LPS3, the process being undertaken to finalise Draft LPS3 before formal submission to the WAPC and how the community can provide submissions on LPS3.

General discussion and comments were made at this time.

The City of Nedlands does not know the rationale behind the changes made to the Council's draft Local Planning Scheme No. 3 (LPS3) by the Western Australian Planning Commission (WAPC) because the matter was considered behind closed doors and any supporting reports have not been made public.

The Mayor has requested a meeting with the WAPC in order to better understand the reasons for the changes but, to date, has had no response.

The draft LPS 3 is open for public submissions from 1 December until the end of March. Open days will be held in February and March 2018 to discuss any specific matters residents may have. All electors are encouraged to make a submission so that the Council has a clear understanding of community views. Once the submission period has closed, all submissions will be assessed and Council will make recommendations to the WAPC for modifications to the draft LPS 3 that reflect the best planning outcomes for Nedlands.

However, it needs to be noted, that the current legislated process does not allow for the Council to make the final decision. The final decision as to the content of LPS3, and any density provisions it contains, rests with the WAPC and ultimately the Minister for Planning.

Tressillian Arts Centre

What plans does the Council have to relocate this important community facility to a more suitable location, or indeed to rebuild the present facility?

Response from the City of Nedlands

There are no plans in Council's forward work program to rebuild Tresillian for the next 10 years. Council will continue to maintain Tresillian recognizing it is an older building. Parking around Tresillian continues to be monitored but no additional off-street parking is planned.

The City has expressed an interest with the State Government to explore the possible use of Building U at Sunset Hospital for Arts purposes. Discussions have continued for the past two years but the State Government has not provided any decision to enable the proposal to be advanced.
