Purpose

The purpose of this report is to determine whether Council wishes to hold a Blessing of the River event and if so, to obtain approval for the expenditure of unbudgeted funds to do so.

Recommendation to Committee

Council approves expenditure of \$4,250 in unbudgeted funds to provide a Blessing of the River event, this expenditure to be incorporated into the midyear budget review

Background

The Swan River Trust has written to the Mayors of Councils with Swan and Canning River frontages, encouraging them to host a Blessing of the River Event in 2012.

The aim of a Blessing of the River event is to promote the river's significance, embrace the Aboriginal history of the local area and make a symbolic commitment to the river's protection over the coming year.

The City of Canning held a successful event last year, with further local governments planning events this year. The Swan River Trust hopes to see the expansion of this event along the river, with it becoming a part of the annual calendar of events for local governments with river frontages.

The Swan River Trust has proposed Saturday 8 December 2012 for this year's Blessing of the River events.

Proposal

Should Council wish to take part, it is proposed that the City would provide a community focused event on Beaton Park on Saturday 8 December 2012.

The event will feature some kind of indigenous entertainment and cultural celebration, in which local community members can take part. Refreshments will be provided and the event will be promoted to the whole community. The educational and environmental aspects of the event will also make it suitable for promoting through the City's 10 local schools. The event will celebrate the significance of the river to the community's sense of place and its importance to both indigenous and non-indigenous people.

As this event has not been budgeted for, should Council wish to proceed with it, approval will need to be given for unbudgeted expenditure of \$4,250. These funds will be used to provide catering, equipment hire, promotion and entertainment.

For the event to proceed, approval of funds will be needed by 30 September and therefore cannot be delayed until the midyear budget review.

Risk Management

As with all events organized by the City, an event management risk assessment will be undertaken before the event in order to mitigate any potential risks.

Discussion

This request from the Swan River Trust provides an opportunity for an additional community-focused event. The event would have the advantage of an interesting focus. It is likely to appeal to all age-groups, from school children because of its educational aspects to older community members because of its historical focus. Positive intergenerational community events help build community cohesion and a strong sense of place.

This specific event also provides an opportunity to link with other celebrations along the river. While the wider networks are not yet developed, if a number of local governments take up the event, in the future they will be able to support each other's promotion of their individual events. The event has the potential to grow into a uniquely West Australian celebration of community, culture, environment and history.

Conclusion

It is therefore recommended that Council approve the unbudgeted expenditure of \$4,250 to host the Blessing of the River Event in December 2012.

Background

The City's Access Working Group is an Administrative Liaison Working Group that provides advice to Administration on issues related to disability access and inclusion. To be eligible for membership, community members must demonstrate expertise in the area of disability and inclusion. Such expertise may include being a person with disability; a parent of a child or young person with disability; and/or working in a disability-related field.

The Access Working Group meets with City staff quarterly.

Proposal Detail

It is proposed that Council appoint a Councillor to be its representative on the Access Working Group, to facilitate communication between the group and Council.

The Access Working Group was originally established to provide a way for Administration to liaise directly with community members with disability expertise. It also assists with the City meeting its statutory requirement to ensure that all consultation undertaken is equally available to people with disabilities as to the community as a whole.
