Council Resolution / Revised Officer Recommendation

That Council:

Recommendation

Purpose

The purpose of the report is for Council to accept the evaluation and recommendation for the award of RFT 2021-22.05 Alterations and Additions to the Swanbourne Nedlands Surf Life Saving Club to Swan Group WA Pty Ltd.

Voting Requirement

Simple Majority.

Background

The Swanbourne Nedlands Surf Life Saving Club (The Club) was identified as requiring alterations and additions as part of the Capital Works Programme for 2021-22. These works will ensure the Club's facilities are adequate for its growing member base, which have outgrown the existing facility.

The Club's storage and changerooms are outdated and are no longer fit for purpose. The Club's current changerooms negatively affect its female members the most. The facilities are housed in an older part of the building that was once a first aid room, before the Club had female lifesavers. This space is smaller than its male counterpart with 4 open style gang showers and 1 toilet for more than 350 female members.

The current changerooms fall short of the National Construction Codes and Australian Standards for both genders. There is no universal access or parental changing space, and this cannot be rectified in the changerooms current configuration.

Similarly, the Club's storage space hasn't been expanded since 1979, and during that time membership has grown 700%. As a result, the Club is unable to keep its lifesaving equipment rescue ready or properly cater for increased Nipper participation.

The scope includes the following works:

- Demolish existing building elements including structural walls,
- Clear and prepare all areas for new construction,
- Pour new concrete slabs and erect structural steel,
- Erect masonry and framed walls,
- Install new roofing members, including replacement of the existing roof sheeting; and
- Complete all works including fit out to a high level of detail.

Originally managed by the Club, the project moved into the control of the City during the 2021/22 budget process, with Council direction to take on the management due to the complexities of delivery. Current funding contributions are shown in the table below:

The Request for Tender was publicly advertised on Tenderlink during the period 25 March – 04 April 2022. The City received a total of 3 submissions.

Discussion

After the closure of the tender period, the evaluation panel completed the analysis and evaluation of the submissions. At the conclusion of the process Swan Group WA Pty. Ltd. was nominated as the preferred supplier for this package of works. The submissions were rated against the following criteria:

- Relevant experience (30%),
- Key personnel skills and experience (30%), and
- Project Methodology (40%).

Swan Group provided information on similar projects that they have recently undertaken, successfully demonstrating an ability to complete the requirements of this request. Key personnel listed were experienced, suitably skilled and have experience delivering similar projects. The project methodology provided by Swan Group was detailed and provided very good information on how the project would be delivered. Quality management was addressed along with preconstruction activities, long lead time procurement items, a dilapidation report, and existing services investigations.

Officers identified that the submission from the tenderer results in a total project cost exceeding the allocated budget. There is currently a high demand for building contractors within the market, and this is reflected in the lack of submissions for the works, and higher than estimated tendered prices.

The City has sought a proportional increase in funding commitment from each grant funding body prior to the letter of award being approved for this project.

Should the project be awarded, works are expected to start in June 2022 and conclude in February 2023.

References were provided by Colin Gardener, Modus Design and Wyatt Brown, of the City of Perth. Both noted that the Swan Group Pty. Ltd. had successfully delivered projects previously, providing a good level of workmanship. Projects were well managed with Swan Group Pty. Ltd. showing a good attitude towards safety management.

Following the due diligence processes that the City has undertaken, the City is confident that Swan Group WA Pty. Ltd. are capable of completing the scope of work to the required standards, and that their offer represents good value for money to the City within the market.

Consultation

Extensive consultation has been undertaken with The Club to ensure the project outcomes meet their long-term needs.

Budget/Financial Implications

The current allocated budget for these works is \$2,106,800 spread across two financial years.

At the time of writing, expenditure is \$121,431 for design and documentation works. The nominated preferred tenderer's submission for construction is \$2,191,155.00. With the inclusion of City Overheads (20% of municipal funding) and contingencies (7% of the construction cost), the anticipated Construction Cost is predicted to exceed the allocated budget.

Administration has sought additional funding from grant bodies and the Surf Club (who have already committed to provide additional funding as per the below table), however these grant bodies are yet to formally approve an increase of their grant funding contribution.

Administration proposes the following budget allocations. If additional grant funding is not provided, additional municipal funding will be required. If this case arises additional funding will be sought at the mid-year review.

Contract variations may be latent (unknown) conditions, or delays at no fault to the Contractor. Should the City agree to a contract and any variations or delays be accepted, the City would be obliged to pay those agreed costs to the Contractor. Therefore, it is recommended that a project contingency be included within the budget.

Federal, State and Lottery West grants cannot be used to fund project contingency or overheads. Therefor these costs are required to be covered by the City and The Club. Overheads are only charged on the Municipal component of funding and increase as Municipal funding increases.

Original construction estimates for the projects were undertaken in 2019, and since that time the construction industry has seen significant increase in demand and prices. The tendered amount is approximately 40%higher than original estimates which matches current market conditions.

Legislative and Policy Implications

The award of this tender is governed by the City of Nedlands Procurement Policy.

The works to be delivered under this contract are in line with the City of Nedlands Asset Management Policy.

Decision Implications

By endorsing the officer recommendation, this project will deliver upgraded facilities that will rectify the above issues and immediately positively impact the Club membership, especially female and junior participation, whilst also allowing the Club to better deliver education, community, and lifesaving programs. Increased storage and change facilities will also allow the Club to take on more new members and offer more community programs.

Endorsing the City to fund the full amount of additional budget will allow the project to proceed to construction without delay, with the current program having works complete before the end of the calendar year. If the City is required to delay award until additional grant funding is received, tender award and therefore construction start will be delayed. This will require construction to impact on a larger proportion of the Club's patrolling season, negatively affecting these activities for longer.

By not endorsing the recommendation, the project will not be able to be proceed, and the Swanbourne Nedlands Surf Lifesaving Club's facilities will remain at a substandard level, negatively impacting member numbers, and the Club's ability to deliver its valued community service.

Conclusion

Swan Group WA Pty. Ltd. have completed public building improvement projects for other metropolitan local governments, have the required skills and experience necessary to complete the works, and are therefore the recommended tenderer for this package of works.

This project will benefit the Surf Club and the wider community by providing better amenity and expanded facilities to the Club.
