Interim Injunction – State Administrative Tribunal

Franco (applicant) V City of Nedlands (respondent)

The applicant sought an injunction (26 March 2015) pursuant to s90 of the *State Administrative Tribunal Act 2004* to refrain the City from revoking its decisions in relation to three development applications for single houses and adjoining properties at Jutland Parade, Dalkeith.

The Tribunal determined to grant the interim injunction sought by the applicant and that the City may not lawfully revoke its decisions of 24 March 2015 in relation to the aforementioned properties, unless certain conditions are met. The Tribunal was also satisfied that the balance of convenience favours the granting of an injunction to maintain the status quo.

Due to the granting of the interim injunction the Special Council meeting of 26 march 2015 did not proceed and the meeting therefore lapsed.
